Main duties include:

To provide specialist housing solutions casework and advice for households with housing needs who are being discharged from a medical or care facility.

Work across the housing, Social Care, and medical facilities to ensure that households due for discharge have needs appropriate accommodation to enable them to leave the medical or care facility.

Work effectively with senior stakeholders in statutory, voluntary and other delivery sectors across (e.g. housing, substance misuse, primary and secondary care, VCS, NHS and social care).

Identify barriers which are prevent discharged from a facility, engaging with officers, services and relevant multi agency teams.

Coordinate, develop and deliver positive outcomes for service users based on the evidence of best practice for therapeutic interventions, using co production principles
