Main purpose of the job:

To support the Corn Exchange management and delivery team to deliver an excellent bar and hospitality service to clients/guests during functions held at The Corn Exchange.

Liaise with stakeholders in a way that promotes the [vision and values](#) of the Council.

Accountabilities and outcomes:

To work with the Operation Manager and Function Manager to deliver all aspects of the bar, its stock and stock management, equipment and glassware.

To operate the venue's electronic point of sale. Handle cash floats and assist with end of shift cashing up.

Present a welcoming, courteous, helpful and efficient service to all clients both before, during and after an event.

To be aware of licensing regulations with regards to the sale of alcohol and your responsibilities.

To work a varied shift pattern in line with function requirements. This includes evenings and weekends with late finishes.

Maintain a high level of cleanliness inside the Corn Exchange Bar at all times and to keep the bar sufficiently stocked during the function.

To undertake secure and accurate handling of all monies in keeping with the Council's financial regulations.

At the discretion of the Head of Service, such other activities as may from time to time be agreed consistent with the nature of the job described above.
