Main purpose of the job:

To learn and develop the skills to:

- assist in the successful running of Medway Council sports centres for the benefit of customers.

- assist sports centre staff in ensuring customers participate in a clean and safe environment.
- assist sports participation team in the successful delivery of sporting events.
- assist sports centre staff in delivery of fitness sessions, swim lessons and sports coaching sessions.

Accountabilities and outcomes:

The successful candidate will undertake a Level 2 Leisure Team Member or equivalent apprenticeship including:

- KBS Leisure Operations
- Swim England Level 1 assisting
